## Instructions for Appendix PU GO

### Production unit(s) behind the production device's metering point

#### General

This appendix is used in connection with the application for the right to allocation of guarantees of origin. All production units that supply electricity to the production device's metering point must be registered in this appendix.

#### Production unit

Type	For biomass/peat/fossil and wind, the type must be indicated according to the alternatives on the form.
Other energy source	The energy source used in the production of electricity. If the energy source is not listed among the preprinted alternatives, mark the "Other" box and enter the energy source on the line.
Unit name	The unit's name used for identification of the unit in the Swedish Energy Agency's registers. If the production device only consists of one production unit, the names of the production device and the production unit should be identical. If the production device consists of multiple production units, names of production units must be chosen so that the respective production unit can be identified.
Commissioning date	The date the production unit was put into service for the first time for continuous production after completed testing.
Installed capacity (kW)	The power capacity of the production unit's generator. If the production unit does not have a generator, the installed electrical power must be entered.
Other information	Information that may be of significance for this application.
