## Necessary content of Technical Documentation Household refrigerating appliances

Household refrigerating appliances are covered by ecodesign requirements according to Regulation (EC) No 643/2009 and requirements by energy labelling according to Regulation (EU) No 1060/2010.

The ecodesign requirements only apply to household refrigerating appliances as described in Article 1 and 2 of Regulation (EC) No 643/2009.

The energy labelling requirements only apply to household refrigerating appliances as described in Article 1 and 2 of Regulation (EU) No 1060/2010.

The documentation shall be produced before the refrigerating appliance is placed on the market.

The technical documentation shall be sufficient to enable assessment of the conformity of the refrigerating appliance with the requirements. In this respect it is important that test reports are included in the technical documentation.
